**Call to Order 10/28/20:** Board Chair Mason opened the board meeting at 6:00 p.m. He turned the meeting over to Vice Chair Victor Mantegna. He presented a written statement of abstention for the record.

Vice Chair Mantegna assumed control of the meeting. He requested an update on projects from Township Engineer Dan Daley. Daley stated that Big Elk has sample homes and open houses. Phillips Mushrooms is moving along nicely. He stated that there remain some outstanding site management issues he is addressing with the school district regarding the mud on Baltimore Pike. Vice Chair Mantegna then introduce Resolution 2020-14 which would authorize the Green Region Grant application in the amount of \$7,500. The motion to adopt was made by Supervisor Sperratore. Seconded by Supervisor O'Connell. All in favor. Motion passed 4-0. Supervisor Mason abstained.
